**Re: Announcement on the Addition of Investor Classification Information for the Indonesian Capital Market**

Dear Sir/Madam,

As part of the efforts of the Indonesia Central Securities Depository (KSEI) to support the Eight-Point Action Plan for Accelerated Capital Market Integrity Reform initiated by the Financial Services Authority (OJK), and to enhance the transparency, reliability, and granularity of investor data in the Indonesian Capital Market, KSEI has introduced 28 Investor Classifications as Corporate (CP) and Others (OT) investor sub-types complementing the 9 (nine) existing Investor Types. Additionally, KSEI has added 21 investor classifications for other investor sub-types.

To provide a technical explanation in support of the completion of the relevant investor classification data, KSEI conducted an outreach session for KSEI Participants on February 3, 2026, which was attended by 114 KSEI Participants.
