- 2) Financial Services Authority Regulation (POJK) Number 10/POJK.04/2020 on Reporting by Registrars or Issuers and Public Companies that Conduct Self Securities Administration; and
- 3) Financial Services Authority Board of Commissioners Decree Number KEP-93/D.04/2022, dated December 28, 2022, on the Appointment and Establishment of the Indonesia Central Securities Depository as an Electronic Reporting System Provider for Registrars or Issuers and Public Companies that Conduct Self Securities Administration; and

7. Multi Voting Shares · Via the Create Special List menu
8. Ultimate Beneficial Owner · Via the Create Special List menu
